**2010 Miss Fashion Australia Awards – Terms & Conditions of Entry Agreement**

**Eligibility:** These national awards are open to all young Australian citizen residents aged between 5 - 27 yrs. Proof of age, identity & current residence in Australia will be required. Please attach a copy to this signed Agreement Form.

**Nomination Fee:** To become eligible to enter the finals of Miss Fashion Australia nominated entrants must sell & register 5 Books of 50 X \$2 Art Union Raffle Tickets (\$500) prior to 1 April 2010. Books of Art Union Raffle Tickets will be supplied to entrants once they sign & return this Terms & Conditions of Entry Agreement to the promoter. **Each finalist facial photo will be posted on our web site to encourage visitors to also support them to win Miss Fashion Australia People’s Choice Award by way of purchasing \$2 art union tickets in their name. \*\*\* 1 ticket = 1 vote \*\*\***

**Major Incentive Prizes:** Entrants whom register lots of \$2 art union tickets will be eligible to win some very rewarding incentive prizes as listed on **Miss Fashion Australia Info Fact Sheet**.
